APPLICATION PROCEDURES FOR CANDIDATES OF FOREIGN NATIONALITY WISHING TO STUDY AT THE CNAM IN FRANCE

The objective of this document is to guide candidates of foreign nationality on the essential steps to follow:

1. CHOOSE A PROGRAM

1.1 You are a candidate of foreign nationality, holding a valid visa or residence permit:

2. APPLICATION FOR ENROLMENT AND / OR VISA

Once the choice of program, has been made, the procedure to be followed depends on several criteria:

- your nationality
- your country of residence
- country of graduation and type of high school (baccalaureate) diploma
- the year (1st or 2nd) of the program you wish to apply for.



2.1 You are a foreign candidate residing in a country covered by the Campus France \underline{cEF} - \underline{ftudes} en France \underline{s} procedure and you have the nationality of your country of residence.

2.1.1 You apply for « Licence 1 » (1st year licence):

- ⇒ If you are preparing for or hold a French or European baccalaureate, you must submit your application at: <u>la plateforme Parcoursup</u> of the procedure <u>"Études en France"</u> until obtaining your visa "étudiant"
- ⇒ If you are preparing for or hold another high school diploma or another baccalaureate, you must submit a Demande d'Admission Préalable (DAP) and apply on the site "Études en France"

- ⇒ If necessary, write to us at: international@lecnam.net
- ⇒ Contact the Espace Campus France in your country of residence for more information.

2.1.2 You apply for 2nd or 3rd year Licence or Master

- ⇒ If you wish to continue your studies in France from the 2nd or 3rd year of licence's or master's degree, you must follow the procedure on the site <u>"Études en France"</u> until obtaining your visa "étudiant"
- ⇒ Create your personal electronic file and follow the guidance
- ⇒ Fill out the application form required by the program and follow the additional procedure if necessary.

2.2 You are a foreign candidate residing in a country not covered by the Campus France "CEF Etudes en France" procedure and you have the nationality of your country of residence.

2.2.1 You apply for 1st year of Licence or Licence 1

- → You must submit a <u>Demande d'Admission Préalable</u> (DAP), « dossier blanc », to be deposited at the Service de Coopération et d'Action Culturelle of the French Embassy in your country of residence.

- ⇒ If your application is accepted, you will receive a document confirming your admission. As soon as you receive this document, you can start the process of obtaining a visa from the French Consulate in your country of residence.

- □ If you hold another type of certificate or baccalaureate, you must submit an Application for Prerequisite Admission (APA) and apply for it on the <u>site « Etudes en France »</u>

⇒ If you are resident in Europe but are a citizen of a non-European country, you must submit a Demande d'Admission Préalable (DAP) to the SCAC of the French Embassy in your home country and apply on the site d'Etudes en France

2.4.2 You apply for 2nd or 3rd year of Licence or Master

- ⇒ Fill out the application form required by the program and follow the additional procedure if necessary
- ⇒ Once you have received your admission letter, you can start the visa application procedure at the French Consulate in your country of residence.
